Introduction

Vision and Mission Statements

The vision statement of the Judiciary of Vanuatu is not radically different to similar statements of vision from other jurisdictions, insisting on fundamental notions like judicial independence, public trust and confidence and effectiveness and efficiency.

However, the vision statement is peculiarly extroverted in seeking to encompass the legal profession into a vision of mutually beneficial standard of expectations of quality, ethical, accessible and cost-effective legal service.

The mission statement is a statement of intent on how the Judiciary of Vanuatu will deliver on its vision and its overarching Constitutional mandate – the administration of justice according to law.

INTRODUCTORY REMARKS FROM CHIEF JUSTICE

The 2022 Annual Report presented in the same format as the previous year but not as detailed due to the unexpected event where the Vanuatu Government network was hit by a ransomware attack that caused all government services and systems to go offline. This impacted the Courts of having no access to our respectful systems over 2 months and data loss, 5 months' worth.

I am pleased to say that this report captured the major performance indicators accepted regionally and internationally. This includes a deeper analysis of the nature of cases registered, completed, and importantly, those pending disposal by the courts. Those indicators indicate that the courts have been successful in achieving results by the end of 2022.

The objectives of Court Administration are equity, effectiveness, and efficiency. The review analyses the ways in and the extent to which the courts in their endeavor successfully perform their roles in the delivery of service to the people of the country.

Further, despite the challenges which are critical to the delivery of justice by the courts, the material contribution of the courts to the community is still unevaluated. This material contribution is reflected in the volume of decisions made. In 2022, the Court of Appeal delivered 38 decisions/outcomes of cases, some of which were substantive judgments and were sent for publication on <u>www.paclii.org</u> and uploaded on the court's website: https://courts.gov.vu.

The publication of these judgments provides valuable information to land, civil, criminal, commercial, administrative, and constitutional jurisprudence. They also enable transparency and accountability in the courts' decision making.

Throughout the year, the Judges, registrars of the courts and courts support staff have administered the courts and the rule of law with a high degree of independence, impartiality, equity, effectiveness, and efficiency.

Implementation of the Management Improvement Plan

The Supreme Court is mandated by the *Judicial Services and Courts Act* to prepare a management improvement plan for each year (*section 50*) purposely for improving the efficiency and effectiveness of the operations of the Judicial Service and the Vanuatu Courts, and to report against it annually (*section 51(f)*) in the Annual Report.

The Management Improvement Plan Outcome: "To improve the capacity of the courts to achieve its mission".

The values that guide the behaviour of the Vanuatu Judiciary and this Plan are:

- Accountability
- > Resilience
- Quality & Timeliness
- Openness & Transparency
- Continuous Learning & Improvement
- Inclusiveness Despite Geographical Constraints

The Management Improvement Plan has again set out five priority action areas.

These five priority action areas were to:

- Maintain and strengthen judicial independence;
- Refine case management systems and processes to endure fair and timely disposition of cases;
- Develop professional judicial capacity building;
- Ensure justice is accessible for all; and
- Develop physical infrastructure/ assets to support effective service delivery.

The Plan highlights the intention to:

- Appoint sufficient judicial and staff resources to enable effective and adequate court services to be provided
- To provide ongoing professional development for judicial and court officers so that the court employees have greater capacity to fulfil their functions
- Develop a grass-roots approach for the courts' engagement with the community by undertaking consultation with court circuits
- Secure funds for infrastructure to ensure accessibility to court services.

Planned Activities summed in Graphs

Judicial Management Improvement Plan 2022 – out of 42 total activities for 2022, 29% was successfully carried out, 19% on good progression (to continue to 2023) and 52% delayed (will be assessed if needs roll-over to 2023).

There were several challenges in implementing the five priority areas, such as funds and for some, priorities changes along the way due to some unforeseen circumstances such as the cyclones, COVID-19 and the hacking of the government network system. Those were lessons learnt and should be improved in 2023.

Some highlights in the JMIP – 2022

- Case Management System (CMS) monthly court performance summary was a success in 2022 (seen monthly released a success until end of October, 2022) – seen an improvement in capacity on analysis of data – seen a good understanding of the monthly summaries as a result seen improvement in court performances for judicial officers and court support staff.
- Audio & video recording is made possible in the Port Vila Dumbea court room and is made upon request of the Judge successfully did 2 audio recordings and 1 video recording this year 2022.
- Sheriff draft manual still on Pilot, was implemented and seen 2 successful Tender sales were carried out in 2022, will continue pilot this year 2023

- The 2019 Family Violence Action Plan for the Magistrate courts seen Acting Chief Magistrate receiving quarterly reports on DV orders and sentencing so as to maintain consistency within the bench.
- The courts through the Hon. Chief Justice have participated in a zoom webinar on 4th October, 2022 on Family Protection Orders on "How they could be just a phone call away" a project to be continued in 2023.

The Court User exit survey report survey was finalised and produced at the end of this year 2022 (A survey conducted for 2 weeks towards the end of 2021 targeting court users). Recommendation for improvements were included in the report and needs actioning.

- The Certificate of Justice Programme introduced to the lay justices of the Island courts, this year will be conducted on Tanna (was deferred from 2022 to 2023 because of COVID)
- Awareness successful awareness carried out by court staff in conjunction with other justice sector made possible through the SRBJs the *Malekula cross sector legal awareness program* to Unua, Espigles Bay and Vinmavis in 2022.
- The courts have successfully participated in the PSC open day at the Convention Centre in 2022. It was a great success, seen court information dispersed to all different age group and an opportunity for court brochures distributed.
- School curriculum Access to justice; the court has taken another step into entering the Vanuatu educational system – introducing the role of the courts. Year 11 has rolled out some topics in 2022.
- The translated course materials (English and French) will be officially handed by the Hon. Chief Justice to the Education curriculum unit early this first quarter of 2023.
- New appointments of judicial officers in 2022
 - seen Senior Magistrate Beverleigh K. Joshua appointed by the Hon. Chief Justice to Chairman for Island Court Land under the Customary Land Management Act.
 - Banks 22 new Island court Justices orientated in 2022, appointed by the Head of State and sworn in by the Chief Justice at Sola.
 - Torres 20 new Island court Justices orientated in 2022, appointed by the Head of State and sworn in by the Chief Justice at Torres.
- New recruitments in court administration seen 6 positions filled and inductions conducted

The Hon Chief Justice and Judge Aru have attended a week workshop in PNG on Judicial officer's Fraud and Corruption from 28 November – 2 December 2022. The PNG Centre for Judicial Excellence has served well the Pacific courts, and this year 2022 has provided the first Training on Fraud and Corruption Workshop for Judges.

Summary of significant developments/ Improvements

Judges – extension of Appointment

• The continuous engagement in the assistance of the New Zealand Judiciary in the form of Judges of the District Court of New Zealand to an interim arrangement on the secondment program to the Supreme Court of Vanuatu after the appointment of Justice Andre Wiltens ending June 2022. Two Judges we appointed on interval of 3 months beginning July 2022 to December 2022.

Judge Christopher Tuohy 18 July to 16 September 2022 Judge Stephen Maxwell Harrop from 14 September to 16 December 2022

• Appointment of New Supreme Court judge

The appointment of Justice Edwin Goldsbrough to Vanuatu Supreme Court bench is an additional support to the Supreme Court after the number of filing continues to increase each year.

• Retirement and resignation

Seeing 3 officers resign this year.

• Termination

Evelyne Kaltapau as the Secretary of Magistrate Court based in Luganville was terminated by the Judicial Service Commission for the following charges.

I. Commits an offence under s.58(c)
II. Commits offences under s.58(f)(i)(ii)
III. Commits an offence under s.58(i)
IV. Commit an offence contrary to section J (ii)

• Extension and transfer of Magistrates

Extension of appointment of Acting Chief Magistrate, Anna Laloyer for a further term of 6 months effective 10 April 2022 and a further term of 3 months effective 11 October 2022.

Land cases

- One Supreme Court Judges focused on land cases and completed 5 Land appeal cases
- Senor Magistrate Beverleigh Kanas was appointed as Chairlady of Island Court(land) for a period of 12 Months.

Expansion of Service to Outer Islands

The insufficiency of the annual budget leads to minimum level of operations in rural centres while the two main towns attract the most voluminous work and therefore the bigger share of the budget expenditure. Despite the budget constraints the court tours to outer islands were effective until limited during COVID19 restrictions.

Interaction with other agencies

- The Judiciary has enjoyed a healthy working and professional relationship with the Ministry of Justice & Social Welfare throughout the year. It has supported the Ministry of Justice Sector Strategy and is in continuous dialogue with the Ministry on carrying the relevant Strategy forward.
- 2. The Vanuatu Police Force has been a major partner in the execution of court warrants around the country.
- 3. The court's interaction with the non-government organizations has been very limited except for the continued cooperation with the Vanuatu Women's Crises Centre [VWC] who represents victims of Domestic Violence in their application to the Magistrates Court.
- 4. The Pacific Legal Information Institute [PacLII] who is accommodated by the University of the South Pacific Emalus campus in Port Vila, has been a strong partner in assisting the Supreme Court and the Court of Appeal judgments to be published online in a timely manner.

International interactions

- 1. Vanuatu benefited hugely from its association with *Pacific Justice Sector Program* [PJSP], a regional cooperation in Judicial Developments, funded by NZ Aid. Six major activities on capacity building for judicial officers and other court developments under 'Access to Justice' were successfully accomplished under this fund in 2022.
- Vanuatu also benefited from its association with the *Pacific Judicial Integrity Program* [PJIP], a new Program that addresses 'Fraud and Corruption' cases coming to court. Vanuatu courts participate in its first ever judicial workshop this year.
- Commonwealth Vanuatu like all other Pacific courts is a member to the 'Commonwealth Judges & Magistrates Association'. Despite COVID-19, Vanuatu maintains strong ties through membership fees, thus benefits from Rule of Law Webinars and other Commonwealth Statements and judicial journal updates, all online.

- 4. Vanuatu continuously benefits from daily updates from *The National Judicial College*, Reno, Nevada, US; on available online seminars and online courses. The judicial officers listened and view some of these online free seminars.
- 5. Vanuatu also has strong ties with the *Papua New Guinea Centre of Judicial Excellence* (PngCJE) and benefits from quarterly Newsletter and PngCJE Updates this year.

Training Development

Court Annual Calendar of events 2022 – a total of 6 judicial development and Training activities was scheduled – only two trainings were successfully carried out;

- ✓ the 2nd Judicial Training for Judges and Magistrates and
- ✓ a secretary refresher Training for the Magistrates court on customer care.

whereas all the other scheduled trainings (Island Court clerks, Sheriff Team and COA Training) were cancelled.

Reasons: The Covid19 restrictions takes more than 3 months in QTR 2, work was resumed back to normal after June.

- The second judicial training for judicial officers has been successfully carried out grouping all judicial officers together, the program design for common and separate sessions and targeting judicial case management – seen a strong year for case finalisation end of 2022.
- A secretary refresher training has been successfully carried out for the Magistrate court staff in Port Vila targeting customer care. Seen an improvement in customer services and work ethic.
- In-house Trainings:
 - IT Trainings on the basic use of court technology devices was conducted by Alick and Jethro with continuous refresher trainings with the CMS by Emma.
 - HR refresher trainings with heads of Units and staff on purpose and the importance to conduct and submit the *Annual Staff performance appraisal reports.*

About the Courts

Court of Appeal

The Court of Appeal is the highest court of the land. It is composed of at least 2 or more Judges of the Supreme Court sitting together. 2021 was a challenging year for the Court of Appeal due to COVID – 19 pandemic restrictions preventing overseas judges from coming to the country to sit in COA sitting physically. However the restrictions encourage the use of remote connection of judges virtually and that works successfully for the sittings COA sittings in February, May, August and November session.

The Chief Justice of the Supreme Court is the President of the Court of Appeal and all the Judges of the Supreme Court are called upon by the Chief Justice to compose the Court of Appeal. Overseas judges who composed Court of Appeal of Vanuatu in 2021 included:

- Justice Ronald Young Retired Justice of the New Zealand High Court
- Justice John William Hansen Retired of the New Zealand High Court
- Justice Raynor Asher Retired Judge of the Court of Appeal of New Zealand
- Justice John Von Doussa Retired Justice of the Federal Court of Australia
- John Mansfield Justice of the Federal Court of Australia
- Justice Richard Conway White Retired Judge of Supreme Court of New South Wales

Supreme Court

The Supreme Court has unlimited jurisdiction to hear and determine civil and criminal proceedings. It has jurisdiction to hear questions concerning elections and similar matters; and it has jurisdiction to hear any grievances from citizens about emergency regulations made by the Council of Ministers. The Supreme Court has jurisdiction to hear civil and criminal appeals from a magistrate's court and to hear appeals from Island Courts as to ownership of customary land. Its decision in such cases is final.

The Supreme Court consists of the Chief Justice and Justices appointed on local terms and conditions. One Justice is seconded by the New Zealand District Court to the Supreme Court of Vanuatu for a period of 2 years. Different Judges of the New Zealand District Court have served on this scheme since 2004.

Magistrates' Court

The Magistrates' Court has jurisdiction to hear cases where the amount claimed or the subject matter in dispute does not exceed VT1, 000, 000; disputes between landlord and tenant where the amount claimed does not exceed VT 2,000,000; and cases involving uncontested petitions for divorce or nullity of marriage.

In its criminal jurisdiction, the Magistrates' Court hears cases that concern any criminal proceedings for an offence for which the maximum penalty does not exceed 2 years

imprisonment. It has jurisdiction to hear appeals from civil decisions from Island Courts, except decisions as to ownership of land, where appeal is to the Supreme Court.

The Magistrates' Court is specifically excluded from exercising jurisdiction in wardship, guardianship, interdiction, appointment of conseil judicare, adoption, civil status, succession, wills, bankruptcy, insolvency, and liquidation. Currently there are 10 Magistrates appointed across Vanuatu.

Island Courts

The Island Court may only deal with civil matters in which the Defendant is ordinarily resident within their territorial jurisdiction or in which the cause of action is within their boundaries, such as customary land cases when the land is within their territorial boundaries.

In criminal matters, the court has jurisdiction to hear charges which their penalties do not exceed VT 24, 000 as fine and not exceeding 6months of imprisonment.

In civil claims, the court hear cases in which the defendant is ordinarily resident within their territorial jurisdiction or in which the cause of action is within their boundaries with claims not exceeding VT 50,000; claims in contracts or tort where the amount claimed, or the subject does not exceed VT 50,000 and claims for maintenance not limited in amount.

The Island Courts are specifically empowered to administer the customary law prevailing within their territorial jurisdiction so far as it is not in conflict with any written law and is not contrary to justice, morality, and good order.

There are currently 10 operational Island Courts in the Republic. The Island Courts have full time clerks, appointed by the Chief Justice to administer the affairs of the Island Courts. There are about 140 active lay justices appointed to decide small claims and minor criminal cases that are lodged in the Island Courts. The lay justices are members of the community.

The coming into force of the Customary Land Management Act has implications for the operations of the Island Court as they are mandated by law to act as the Island Court [land] Tribunal registrars to receive applications on review decisions of customary land ownership from the village level.

Court results (Court workload)

Court of Appeal workload & clearance rate

Cases filed has decreased by 33% in 2022, compared to 2021 a good thing showing less appeals.

Clearance rate at 89% less than 100%.

Supreme Court workload & clearance rate

Supreme Court filing decrease by 12% and case disposal decrease by 14%. Clearance rate of 101 % is slightly lower, compared to year 2021.

Magistrate Court workload & clearance rate

Magistrate Court filing decreased by 13% and case disposal decreased by 7%, in 2022 however, clearance rate sitting at 102% an increase compared to the year 2021.

Island court workload & clearance rate

Cases filed has decrease by over 38%, and disposals 66% in 2022. Clearance rate at 58% the lowest we have ever seen – needs further investigation.

Clearance rate

Just of over 3,400 cases filed across the four jurisdictions, a 17% decreased compared to the year 2021. A clearance rate of 98%, but 3 out of 4 jurisdictions better than 100%.

Pending Cases by Court

2,465 cases are now pending across the four jurisdictions, with 33% in the Supreme Court. Of concern is the high Pending to Disposal Ratio (PDR) in the Island Courts. The lower the PDR, the better - and ideally under 1.0 for the Supreme Court and 0.5 for the lower courts.

Commentaries

Supreme Court

- SC filings just above 700, less than last year 2021 with 723 cases filed.
- SC disposals while not as in year 202, less with 733 cases closed.
- Clearance rate again was greater than 100% at 101%, an excellent result.
- Pending remains just over 800.
- PDR is I.I just above the target for any Supreme Court
- Timeliness for completing Criminal cases slightly increased now at 183 days versus 174 last year. Civil cases also reduced from 652 days to 473 days a great result.

Overall

• Attendance rates (which impact and cost to the parties) continue to being monitored carefully. An increase in attendance for criminal and enforcement and a decrease in civil, while others are stable.

Magistrate Court

- MC filings decrease significantly from 2638 to 2283 a decrease of 13%
- MC disposals decrease from 2506 to 2336 cases, a decrease of 7%
- The clearance rate increased greater than 100% to 102%, an excellent result.
- Pending at 918 cases a decrease to 2021

- Timeliness for completing both Criminal and Civil cases a slight increase, 164 to 177 days for Criminal and 353 to 377 days for Civil.

Overall

- Pending case numbers (open cases) decreased slightly due to the Clearance Rate more than 100%
- The Pending to Disposal Ratio (PDR) is solid at 0.4.

Island Court

- IC filings decreased by 38% from 553 to 345 cases filed, compared to 2021.
- IC disposals decrease by 66% from 592 cases to 199, the lowest we have ever seen needs further investigation.
- Clearance rate well below 100% at 58% the lowest we have ever seen.
- Pending cases increase to 701 cases compared to 2021.

Percentage of Appeal

The percentage of cases that goes on appeal in the Court of Appeal is calculated using the number of cases finalized in the Supreme Court and the number of appeals registered in the Court of Appeal as a percentage of the later. 723 cases were finalized by the Supreme Court in 2022, and 55 cases were appealed to the Court of Appeal. This represents 7.6% of all cases finalized in the Supreme Court that were appealed.

Overturn rate on appeal is 36 %

Fee waiver

The record of cases that are granted fee waiver is not updated due to the government network hack in 2022 – seen none.

Cases disposed on circuit

The percentage of cases disposed through court circuit is not updated for both Supreme and Magistrate court.

Factors, events, or trends influencing court results.

The Vanuatu Courts enjoy a good degree of independence from the executive branch of the Government. However, external and internal factors contributed to the results of the court operations and functions in 2022.

Challenges

- 1. The 3 months Covid19 restrictions no full-time office operation beginning March and resuming after June. Most hearings affected.
- 2. The missing data during the government hacking 5 months' worth data.
- 3. The non-service of summonses for criminal cases lodged in the Magistrates Court has a great impact on the Magistrates Court in managing cases.
- 4. Court circuits to islands other than Efate and Santo have been limited to Provincial headquarters due to limited resources.
- 5. Warrant issued by the Supreme Court and Magistrate Court for defendants in criminal cases were never executed due to inability of budget or resources by the Vanuatu Police. Some of these pending warrants were over 10 years old.

Judiciary will continue to encourage staff to take annual leave where possible and find avenues where leave balances can be paid off so that in the next 2-3 years, we would like to see leave balances at a manageable status for the institution.

B. Override of accurate leave records

FTE who has worked over 20 years leave balances still needs to be updated in the system (10 staff only). Follow-up will continue this year with the FMIS team to ensure the override is implemented for this specific grouping.

5. Staff welfare

Most of the Staff employment statuses are permanent, receiving all entitlements. Salaries are paid fortnightly for the last 12 months.

6. Office Hours

Most staff attend work by 7.30am to 8am; Each Courts has a time record sheet in place. HRO provides an up-date report each month to the Chief Registrar on the status of staff timing. Reminders to staff regarding timing are provided to staff where necessary so that Official hours of work are respected by staff.

Day-off is granted to staff for work done on weekends or Public Holiday or when they travel during weekends for work purposes. Day-offs are tracked and Managed by HRO.

7. Discipline

In the year 2022, there was no termination of staff by the Judicial Service Commission.

8. Record Keeping

Court staff and judicial officers each have their own personnel file in both SOFT & HARD COPY of which the HRO have access and updates the files.

The Budget execution and management

Judiciary's execution of budget in 2022 have been managed to its very best to meet most of the request that were brought forward which required budget.

Not all activities that were listed in the Judicial Management Improvement Plan and court yearly planner and calendars were executed. Some required further discussions and need more work to be done before its implementation.

The operation budget of the judiciary did not reflect the reality of all activities such as the annual calendar of events, all judicial officer entitlements, the day to day running of all court's registries around the country.

1. Statement of Appropriation

Allocated payroll budget was 68% or VT 223,455519. The payroll expenses above shows that Judiciary overspent its budget by VT 2,783,784.

Major Spend Accounts

The major spending was from Judges Gratuities, Housing allowances, Provident Fund, Leave expenses and Permanent wages.

Major Underspend Accounts

The major underspent payroll accounts were from gratuities, housing, and permanent wages. This indicates that Judiciary did not formalize all the recruitments in year 2022.

Major Overspend Accounts

The major overspent payroll accounts were from acting allowances, responsibility allowances, home island passage allowance and leave expenses.

Each account will be justified the reason of being overspent.

- i. Acting allowances- No budget under acting allowance account for the reason that institution planning not clear.
- ii. **Responsibility allowances** Judiciary budget VT 900,000 under responsibility account. Along the year, there are decisions which arise that required to compensate some staff for doing additional job apart from their JD's. This has led to overspent under this account.
- iii. **Home island passage allowance** No proper planning for staff to take Home Island leaves thus no proper budget under this account. More budget can be allocated to this account, but it will be a waste if staff do not take-home island leave.

iv. Leave expenses – No funds were allocated to leaves account. Outstanding leaves were paid by payroll savings.

In year 2022 four Judicial Officers outstanding leaves were paid.

- b. Master Cybelle Cenac resigned.
- c. Chief Justice, Hon. Vincent Lunabek- difference of 200 days been paid for end of year 2021.
- d. Judge Oliver Saksak- difference of 200 days been paid for end of year 2021.

The allocated Operation budget was 32% or VT 103,979,339. The operation expenses above shows that Judiciary had spent 103,908,127 million and had under spent its 2022 operation budget of 71,212 thousand Vatu.

Major Spend Accounts

The major spending was under subsistence allowance account, sitting allowance account, local accommodation account, Vehicles fuel account, transport freight account, office cleaning account, translation account, printing, stationaries account, telephone account, office rental account, refund account, official entertainment account, building repair account, vehicles repair & maintenance account, local travel account, electricity utility account, VAT account, equipment additional general account and equipment computer account.

Major underspend Accounts

- Subsistence allowance- This account was underspend because of the COVID19 locked down which affects most of the court tours to outer islands.
- International accommodation- No international travel due to COVID 19 being locked down.
- Local accommodation- This account was underspend also because of COVID19 lockdown which affects most of the court tours to outer islands.
- Software maintenance fees- This account was underspend because in 2021, payment was made twice so in 2022, we just pay the difference.

- Other fees- Most of the fee's budget under this account is for sheriff execution fees example, valuation fees.
- Advertising communications- COVID 19 also have impacts on Sheriff planning to execute the court judgements. Court judgements involves people's lives. Most enforcements are out in different media outlets.
- Office rental- When court tours to outer islands, we normally hire halls, nakamals and other rooms for court hearings. COVID19 also contribute to under spending under this account.
- Other rental- Two Judges housing allowance are kept under this account. 1 Judge Position still vacant. Another judge was recruited in 2021 but his housing was paid under project fund. Thus, result on savings under other rental account.
- > Vehicle replacement- In 2022, Judiciary did not purchase any new vehicle.

Major Overspend Accounts

- Sitting allowance- Judiciary budgeted VT 25,137,523 and overspent VT 2,278,022. In 2022 there was an additional urgent court of appeal sitting. There were also additional land cases which contribute to this account to overspend.
- Transport Freight- This account was budget for excess of court files during court tours, freighting baggage's to outer courts, international freight when purchasing items. In 2022 Master of the Supreme Court employment ended and Judiciary must ship all her belongings back to her home country.
- Translation communications- This is a major activity in court which has become very demanding and needs urgent attention. Not enough budget was allocated for this specific activity thus is affecting other court activities.
- Stationary communications- This account is always under budget due to different needs among different courts; however, A4 photocopy papers, manila folders, and archive boxes, envelopes, and pens are some items that were frequently purchased.
- > Building repairs & maintenance- Major work done under this cost center were:
 - Roofing of two 20-foot containers containing court archives.
 - Supreme court registry roofing repair
 - Ceiling repair at supreme court registry
 - Lakatoro court room repair
 - New fence around Efate Island court.
- Vehicle repairs & maintenance- Judiciary has 16 vehicles altogether. These vehicles are over 5 years and continuously needs parts & maintenance.
- Local travel- Judiciary budgeted 5 million under this account and overspend by 1 million. This is due to some urgent travel that is caused by flight cancellation and administration must charter airlines.
- > Electricity utilities- This account also overspent due to the increase of fuel prices.
- Value added tax- Since Vanuatu Government increase VAT percentage, it did not allocate additional budget to Judiciary.
- Equipment-Additional general- Additional telephone and video conferencing equipment was purchase for installation in Tanna and Malekula court. New air-conditions were purchased and install in Supreme, Magistrate and Efate Island Court.

Equipment-Computer-In 2022 Judiciary replaced more than 10 computers plus purchase of new printers.

Advanced Release

 - a. Port Vila Supreme court hearing room rental 1st agreement date was 2007 for a period of 3 years expiring in 2010. The agreement was never renewed to date.
 - b. Santo Supreme court office rental rental agreement renewed for another 5 years starting 2020 to 2025.

- c. Magistrate court office rental rental agreement renewed for another 2 years starting 2022 to 2024.
- d. Magistrate court hearing room rental rental agreement for 2 years starting 2019 to 2022.
