Spokesman Jack KALON hemi talem in general nomo se hem (Jack KALON) i also spokesman blong defendant ia. Since court ie notisim se defendant ia hemi no filem eni defence statement blong hem long case ia, court ie decide blong proceed stret i go long second defendant.

Second (2nd) Defendant: Jack KALON

Jack KALON i konfemem long court se hemi namba 5th Generation mo hemi descendant blong Touran (3rd Generation) blong Chief MASEIMERMAN blong Erakor village, South Efate. Hemi konfemem tu long court se long June 1999 Tribe or Klan or Naflak Nmaal we oli main descendants blong Apiu mo Touran long Erakor i bin holem wan miting lo Nakamal blo Allen Kallon blong putumap wan kometi mo jusum hem olsem jif blong olketa. Hemi konfemem tu long kot se title ia MASEIMERMAN hemi blo clan o naflak Nmaal nomo we oli stap kivim long jifs blong olketa follem history we ol olfala oli bin passem daon i kam long olketa. Hemi konfemem tu se rison ia nao Apiu taem emi laef yet oli stap kolem hem *Marik Maama* be oli neva kolem hem MASEIMERMAN. blong woman mo konfemem se olketa everiwan i descendants blong Apiu mo Limor. Hemi lastly konfemem se title ia emi blong olketa everiwan be Naflak nao i holem mo hemi acceptem Family Tree we claimant i putum istap se emi blo olketa everiwan tu.




COURT FINDINGS:

Afta court i readim, hearem mo considerem every statement mo ol documents blong ol parties mo every witness blong olketa;

Mo bageken, afta we court i **cross-examinem** every parties mo every witness blong olketa, findings blong court hemi osem:

1. Name ia MASEIMERMAN emi wan customary title blong wan chief;
2. Name ia MASEIMERMAN emi no wan Family Name;
3. Every witnesses blong every parties mo olgeta defendants oli akri long Family Tree blong claimant;
4. Every witnesses blong every parties wei oli testify long court oli related mo oli wan bigfala family nomo we tuketa i kamaot long wan stampa or same Family-Tree blong Chief MASEIMERMAN;
5. Claimant emi nokat wan custom Nasara, Nakamal or Farea we emi exist under long Custom Governance blong hem so that bae hemi save yusum blong performem olgeta custom duties mo responsibilities under long custom jurisdiction blong hem;
6. Claimant emi stret male bloodline we emi kamaot long Generation no. 7 long Family-Tree blong Chief MASEIMERMAN;
7. Every witnesses blong claimant mo claimant oli testify long kot se i bin kat wan kastom ceremony long date ia 8th August 2015 long Ewentau Station long Eratap we ol authorities blong Rutau Family ibin ordainem Charlot Nawen RUTAU mo kivim chiefly title name ia "Chief Rutau Maseimerman" or "Marik Rutau Maseimerman";
8. Claimant emi bin ordained by Chief Kalsaur POMAL VIII long 15th August 2015 long Erakor village mo givim name ia Marik Rutau MASEIMERMAN;
9. Second Defendant emi bin stap usum name ia MASEIMERMAN finis long Year 2004; Refer long "Eratap Customary Lands Tribunal Land Case No. 1 OF 2004 – Location : NAISRAPER area-ETAS Area, SOUTH EFATE";
10. Olketa Defendants oli neva disputem Chiefly Title ia MASEIMERMAN afta ordination blong Claimant long date ia 8th August 2015 long Ewentau Station, Eratap Vilij mo 15th August 2015 long Erakor village;
11. Some long olketa witnesses blong Claimant wei oli kamaot long saed blong Naflak NMAAL or woman bloodline oli maintenem position blong olgeta blong sapotem mo konfemem se Charlot Nawen RUTAU hemi rightful kastom owner blong name ia MASEIMERMAN follem male bloodline mo tu kastom blong Erakor mo South Efate;
12. After Generation No. 7, olgeta Defendants i just kamap blong disputem title ia MASEIMERMAN nomo after wei claimant ie askem court blong declarerem hem se hemi rightful ona blong Chiefly Title ia, MASEIMERMAN;
13. Trifala defendants ia Jack KALON, John MARKAL mo Kaluat JOSEPH i prodiusem wan Family Tree nomo wei ie kavremap everywan, hemia ie excludim 1st defendant Andrew Bakoa KALPOILEP;



14. Every parties wei oli present long court mo olgeta witnesses blong olgeta oli akri se First Defendant emi no bloodline or even wan descendant blong Chief MASEIMERMAN based long Family Tree blong claimant mo Family Tree blong 2nd, 3rd mo 4th defendants;
15. Family-Tree we trifala defendants ia Jack KALON, John MARKAL mo Kaluat JOSEPH i prodiusem long court hemi no complete mo i nogat any link blong inheritem Chiefly Title ia MASEIMERMAN follem kastom blong South Efate;
16. Second Defendant ino stret person blong karem title ia MASEIMERMAN taem hemi konfemem long kot se hemi holem smol taem nomo kasem ol Nematrau oli faenem stret man blong em;
17. Olgeta Defendants ie talem se full name blong MASEIMERMAN hemi 'WITAU MASEIMERMAN' be oli no pruvumaot long court ol evidence blong sapotem statement ia;
18. Even though claimant mo Jack KALON, John MARKAL mo Kaluat JOSEPH i kam anda name ia MASEIMERMAN base long Family Tree blong Claimant, yet spokesman blong defendants emi insist long court se emi wan mistake blong Charlot Nawen RUTAU blong ordained long Chiefly Title ia, MASEIMERMAN but hemi (defendant's spokesman) fail blong pruvumaot statement blong hem long court;
19. Olgeta defendants oli no aware long ordination blong Claimant we ie happen long Ewentau, Eratap village long Chiefly title ia MASEIMERMAN so oli talem se i no tru;
20. Second Defendant oli choosem hem nomo blong representem or act long behalf blong name ia, MASEIMERMAN be hemi no pass tru long customary process mo ordination blo karem wan chiefly title name, follem kastom blong Erakor mo South Efate;
21. Even though Claimant mo Defendant i konfemem se tufala i wan family nomo, court ie faenemaot se olketa oli neva kat ol meeting tuketa, mo ol toktok blong kam tuketa i always fail kasem taem wei claim blong chiefly title ia, MASEIMERMAN ikam long kot;
22. Most long ol witnesses blong Claimant oli konfemem se Claimant emi karem chiefly name ia, Chief Rutau MASEIMERMAN long wan seremoni long Ewentau, Eratap village and recommendation iko long Chief Kalsaur POMAL VIII blong Erakor village blong finally ordainem hem mo name ia, Marik RUTAU MASEIMERMAN long Erakor village long 15th August, 2015.
23. Claimant ino kamaot long Naflak NMAAL be hemi kamaot long male-bloodline follem Family-Tree we hemi provaetem blong Chief MASEIMERMAN.
24. Second Defendant hemi konfemem tu se hemi no kamaot long Naflak NMAAL be hemi kamaot long woman-bloodline follem same Family-Tree we hemi (Jack KALON) provaetem mo claimant i agree long em olsem wan big family blong Chief MASEIMERMAN.
25. Second Defendant i konfemem long cross-examination se hemi no qualify blong tekem chiefly title name ia 'MASEIMERMAN' from hemi wan SPECIAL TITLE blong ol Naflak NMAAL nomo we ol narafala tribe or Naflak oli no save yusum;



26. Even though Defendant i talem se kastom jif blong Erakor i no follem bloodline for the last 120 years be Chief POMAL 1, first ever Chief blong Erakor long year 1861 emi follem male-bloodline taem emi start lukaotem ol pipol blong Erakor village;
27. Second Defendant emi believe se oli berem Late Chief MASEIMERMAN (1st Generation) long Emeltafra hemia long Erakor long haos blong 2nd Defendant, be i nokat evidence se grave or Historical burial site emi blong hem (Chief MASEIMERMAN long 1st Generation);
28. Second defendant Jack KALON emi konfemem se First Defendant Andrew Bakoa KALPOILEP emi no bloodline mo descendant blong Chief MASEIMERMAN.

Findings blong court afta wei hemi gat site-seeing wetem ol parties:

29. Chief MASEIMERMAN emi startem wokabaot blong hem long wan ples we oli singaotem 'Naisraper' be inokat evidence se hemi bin live long ples ia mo inokat eni cultural burial site blong hem follem claim blong Claimant.
30. Defendant emi no challengem sem ples ia we claimant i talem mo konfemem long kot se Chief MASEIMERMAN i startem wokabaot blong hem tu long area ia, 'Naisraper'.
31. Claimant emi claim se Chief MASEIMERMAN emi kat wan (1) historical 'tabu' stone or rock we emi stap kivim kud luck mo security long sem area blo Naisraper.




