Itru se Daniel Obed hemi kaon long kava seedlings mo juice blong Morsen Haruel?


Sipos hemi tru, why nao ino save pem bak?

**Full storian:**

Hemi bing karem 100 seedlings blong kava mo kava juice we total blong hem nao hemi 22,350VT. Be long taem ia ikam kasem today, hemi neva perm ol samting ia.
